



Board Member Commitments and Responsibilities

The MBA Board of Directors is the governing body of the Association. Its members are legally, fiscally, and morally responsible for the leadership of the Association. Their decisions and actions influence the culture of the Association by setting an example for all its members.

The Inspire Mishawaka Board of Directors is the governing body of the organization. Its members are legally, fiscally, and morally responsible for the leadership of the Organization. Their decisions and actions influence the culture of the Organization by setting an example for all its members.

Inspire Mishawaka is a newly incorporated 501c(3) nonprofit organization which originated as an initiative of the Mishawaka Business Association. While the mission and vision for each organization is complementary to each other, the Mishawaka Business Association has an obligation to businesses across the entirety of the city while Inspire Mishawaka has focus on a core downtown district. Additionally, each organization benefits from nonprofit classification which serves their respective purposes:

Mishawaka Business Association – 501c(6) – which is a membership-based organization that exists to promote its members' business interests without the goal of the organization itself making a profit. Its mission is: To promote the growing business environment in Mishawaka. To be a resource and advocate for the Association's members while supporting, facilitating and enhancing commercial opportunities in the city.

Inspire Mishawaka – 501c(3) – structured as a tax-exempt nonprofit community organization to organize and promote economic vitality in downtown, including its architectural and historic fabric. Its mission is: To be a catalyst for growth in activity and commerce in our historic downtown.

These two organizations must exist independently to fulfill their respective mission and organizational obligations with the IRS and to qualify at least one as a 501c(3) for OCRA and Main Street partnerships. However, there is an obvious benefit for the MBA and Inspire Mishawaka to collaborate rather than compete in promoting business activity in our community. They maintain separate bylaws, but a common board of directors.

Board members are elected by the General Membership of the Mishawaka Business Association on an annual basis and confirmed by the current Inspire Mishawaka Board. Board members hold office for a term of 3 years beginning on January 1st on the year of their election.

Nomination Process & Eligibility Requirements

Board members are slated by the Board of Directors and elected by the General Membership of the Association at the annual membership meeting.

Board members hold office for a term of 3 years beginning on January 1_{st} of the year of their election, or the remaining term held in the case of filling a Board vacancy. The Board is led by an Executive Committee of its elected officers (President, Vice President, Secretary/ Treasurer, and Past President). All other Board members are considered "At-Large" and are encouraged to also participate in an MBA/Inspire Mishawaka task force or committee.

NOMINATIONS

Nominations for 2024 Board of Directors members are now open. All nominated and eligible candidates for Board office will be contacted by the MBA/Inspire Mishawaka Nominating Committee and presented to the current Board of Directors who will assemble the proposed Board Slate for 2024. The 2024 Board Slate will then be presented to the MBA membership for its approval. Nominated candidates must be present at the Annual Meeting, eligible for the position, and must agree to serve.

Additional Nominations may be made from the floor at the Annual Meeting of the Members. If no additional nominations are made from the floor, the nominations shall be considered closed. In the case that additional nominations are made from the floor, proxy voters who had voted previously would be contacted to re-open the vote based on the modified slate, only if proxy voting is needed to achieve a quorum or if it could potentially impact the outcome of the vote. Otherwise, the voting will be considered closed during the Meeting of the Members.

QUALIFICATIONS

To be eligible to serve on the Board of Directors, nominees must be a Member of the MBA, committed to serving a 3-year term, able to regularly attend meetings the morning of the 2nd Friday of each month, and elected by the General Membership.

VOTING

The 2024 Annual Meeting and subsequent Board of Directors vote will be held at 8:30am on Friday, January 13th in the Battell Center auditorium. Voting in person by current Board members is highly encouraged.





Board Member Commitments and Responsibilities

Introduction

This board member agreement is the promise a board member makes when accepting a position on the Mishawaka Business Association/Inspire Mishawaka (MBA) Board of Directors. It is not a legal document but an internal agreement, asserting the board member's commitment to the organization in addition to an understanding of the general board responsibilities.

Additional Notes

This agreement serves as a general commitment for all members of the Board of Directors, including Officer positions, Committee Chairs as well as at-large Board members. There are separate job descriptions for the Executive Committee and Committee Chairperson roles. It should be clear that whether a board member signs this form or not, the State of Indiana nonprofit corporation laws automatically impose certain fiduciary duties on nonprofit board members. Board members should be aware of those legal duties and obligations when they assume their positions. (Typical fiduciary duties imposed by law include the Duty of Care, the Duty of Loyalty, and the Duty of Obedience, all of which require a certain level of diligence and prohibit conflicts of interest.)

In exchange for service on the Board of Directors of the MBA, the organization agrees to provide each member of the board with the following:

- 1. Access to the management of MBA, as needed for proper operation of the board
- 2. Ample notice of all meetings
- 3. Minutes of all board meetings
- 4. Relevant information to conduct his or her job as a board member
- 5. To the extent allowed by law, indemnification from liability for a board member's reasonable and necessary actions
- 6. D&O insurance liability coverage
- 7. Respect for his or her time
- 8. The use of his or her talent effectively
